Organizations

NASET: National Association for Special Education Teachers (naset.org). Not much on this site is free (parents can become members, however), but if you join they are a wealth of information on everything from special education interventions, to diagnoses, to accommodations. They offer several training programs in advocacy and special education.

COPAA: Council of Parent Advocates and Attorneys (copaa.org). This organization focuses specifically on promoting education advocacy and special education law. This website is worth the money in membership for the forums alone.
